1. Pursuant to authority contained in Paragraph 4, Section 5, War Department Circular 127, dated 29 May 1943, and Classified Radio from Headquarters Rear Echelon, CBI, dated 20 May 1944, you are hereby relieved from further assignment and duty in this theater and will proceed from this station by first available air transportation to the United States reporting upon arrival in the United States to the Commanding Officer, Air Gateway, Miami Beach, Florida for further orders and instructions.

2. Air priority number APR-4-THE-1336-AAF is authorized.

3. Travel by military or commercial aircraft (under the provisions of Section IV, War Department Circular No. 12, 1942) by belligerent vessel or aircraft, commercial steamship or rail is authorized.

4. Duties to be performed being exceptional a delay in excess of 72 hours but not to exceed thirty (30) days in any one place is authorized.

5. In lieu of subsistence a per diem of seven (\$7.00) dollars is authorized the above named Officers in accordance with existing laws and regulations while traveling, except at points where temporary duty is performed and Government billets are provided, in such cases the per diem will be three (\$3.00) dollars. Where Government rations and quarters are furnished the per diem will be suspended.

In lieu of subsistence a per diem of seven (\$7.00) dollars is authorized the above named enlisted men in accordance with existing laws and regulations while traveling by air. For travel by other means it being impracticable for the Government to furnish necessary messing facilities for rations and quarters in kind the Finance Department will pay the monetary allowances in lieu thereof and for periods of temporary duty where rations and quarters are not furnished in accordance with AR 35-4520 as amended.

6. A baggage allowance of seventy-seven (77) pounds is authorized.

7. The travel directed is necessary in the military service. 91-3 P 431-02:A 212/40425.

8. Notify all correspondents and publishers to discontinue mailing letters and publications until further advised as to new address. V-Mail Notice to correspondents and publishers may be used for this purpose.
