Dear Miss Patty:

I am collecting a genealogy of descendants of the Washington family, with particular emphasis on the various families descended from General Washington's prothers and sister. I have had a good deal of difficulty learning about some of the families descended from fielding Lewis, Jr., who is your ancestor, and am writing to ask your assistance.

It has been proved to my satisfaction through records relating to the division of the estate of General Washington that Fielding Lewis Jr and Ann Alexander his wife were survived by only seven children, though we know the names of the two others who must have died before their father. But a couple of these children have thus far eluded me, and disappear into the mist.

Judge mesekiah William Foote, your ancestor, seems to have handled the correspondence and transactions for the heirs of fielding Lewis, Jr., with the executors of meneral mashington's will, after he married Lucinda frances Dade about 1838, and he seems to have owned various Washington relics. I am wondering if his papers and correspondence survive in the possession of any descendants of the family. It has even seemed probable to me that there might somewhere in your family be an old family Bible showing the dates of birth of the children of Fielding Lewis, Jr., or perhaps at least the births of the children of Henry Chew Dade and Catherine D. Lewis. Certainly there seems a chance that his papers might include letters from the various relatives among whom any final payments from meneral Washington's estate would have been divided, showing where and when the various descendants were living in the 1840's.

Ultimately - should like to collect a complete list of the descendants of this part of the family. I already have some fairly extensive notes and enough to show that the family must be very numerous. Any information you could give me to show the grandchildren and further descendants of Judge Foote by his first two wives kind (Lucinda Frances Lade and Mary Foote) would be most welcome indeed. I am hoping that you will turn out to be descended from Mary Foote, the daughter of Lucinda Lewis and Gilson Foote, and be able to tell me more about her and her brothers and sisters.

I shall enclose a list of the children of Fielding Lewis, Jr., as I now suppose them to be, indicating some of the problems I still have. I shall be most grateful for any help you or any member of the family can give me.

I have a fair amount of information about the ancestors of Fielding Lewis, Jr., and Ann Alexander, and would be happy to try to answer any questions you might have in this area,
