 all to whom these presents shall come greeting Know ye that in consideration  
 of the ancient composition of Thirty Shillings Sterling paid by Samuel Hairston  
 into the Treasury of this Commonwealth there is granted by the said

Commonwealth unto the said Samuel Hairston a certain Tract or parcel  
of Land containing two hundred and Eighty seven Acres by Survey bearing  
date November the twenty ninth One Thousand Seven hundred and fifty  
two Lying and being in the County of Lunenburg on the Branches  
of Seneca Creek and bounded as followeth, to wit, Beginning at  
Murrays cornered Oak on Mansby's Line thence on Mansby's Line  
North Eighty eight degrees East two hundred and forty poles to  
a Black Birch thence off South eight degrees West one hundred and  
Eighty six poles to a Double pine thence South seventy four  
degrees West one hundred and forty six poles to a small shrub white  
Oak on Wilson's Line thence along his Lines North forty seven degrees  
West twenty poles to his cornered Oak thence South thirty four  
degrees West forty eight poles to a Red Oak thence off North seventy  
two degrees West sixty poles to a shrub white oak thence North nineteen  
degrees West fifty six poles to pointers on Murrays Line thence along  
his Lines East ninety Poles to his cornered Profession tree in a Meadow  
thence North thirteen degrees West one hundred and eighty Poles  
to the first Station, with its Appurtenances, to have and to hold the  
said Tract or parcel of Land, with its Appurtenances, to the said Samuel
