 aforesaid: Now this Indenture further Witnesseth that the said Sally Baker
 for and in consideration of the love and affection which she bears to
 her said grandchildren Sally T. Rowland James M. Rowland and Peter

Rowland as well as of one dollar to her in hand paid by the said Harain Hairston their Guardian: hath given granted bargained sold and delivered & by these presents doth give grant bargain sell and deliver over to the said Harain Hairston Guardian as aforesaid all the right title and claim which she has under the will of the said James Baker dec'd in and to the following slave to wit one negro woman named Patt and her Increase to be held by the said Harain Hairston Guardian as aforesaid for the use and benefit of the said Sally J. Rowland James M. Rowland and Peter M. Rowland until such time as the said slave and her future increase can be divided amongs said wards. This Indenture made this 14th day of August in the year one thousand eight hundred and thirty two by and between Edward Pease of the county of Henry and state of Vir. of the one part and Daniel Easton of the Co. and Sta. aforesaid of the other part: Witnesseth whereas the said Edward Pease for and in consideration of the sum of eight hundred dollars in hand paid at and before the sealing and delivery of these presents the receipt is hereby acknowledged he the said Edward Pease hath given granted bargained sold alien unfeoffed and confirmed and do hereby give grant bargain sell alien unfeoff and confirm unto the said Daniel Easton one certain piece parcel or tract of land lying and being in the county of Henry and state of Virginia on the grassy fork of Town Creek and containing twenty four hundred and seventy acres be the same more or less and bounded as follows.
